

**VEDTEKTER/ ARTICLE OF REGULATIONS**  
for  
**Initiative for Children's Right To Education**  
In Memory and Tribute to: Nanne Andrea and Solveig Davies Landa  
(pr 15.05.2008)

**§ 1. Navn/Name**

Stiftelsens navn er: Initiative for Children's Right to Education og er en stiftelse. Stiftelsen er en alminnelig stiftelse./

The name of the foundation : Initiative for Children's Right to Education . The foundation is a general foundation.

**§ 2. Lokalisering/Localization**

Stiftelsen er lokalisert i Trondheim kommune./ The foundation is localized in Trondheim municipality.

**§ 3. Formål/Objectives**

Stiftelsens formål er å jobbe for å gi vanskeligstilte barn på Filippinene mulighet for utdannelse.  
The Foundation's objectives are to offer a possibility of education to poor and unfortunate children in the Philippines.

**§ 4 Grunnkapital/ Base Capital**

Stiftelsens grunnkapital er på kr. 100.000,-/ The Foundation's base capital is NOK 100. 000.

**§ 5. Styret/ Board**

Styret er stiftelsens øverste organ, og er den som velger styret. Stiftelsen styre skal ha 1-4 medlemmer Styret velges for to år om gangen. Styremedlemmer kan ta gjenvang. Dersom der er stemmelikhet ved avstemninger i styret, skal styrets leder ha dobbeltstemme. Det utbetales ikke honorar til styremedlemmene.

Daglig leder tilsettes av styret. Styret kan bestemme at stiftelsen ikke skal ha daglig leder, eller at stiftelsen skal ha flere daglige ledere./

The board is the supreme agency of the foundation, and is the electing body. The board shall constitute 1-4 directors. The board is elected every two years. Board directors may be re- elected. An equality of votes with regard to votes within the board, the chairman of the board has the casting vote. There is no disbursement of salary for the directors of the board.

The general manager is appointed by the board. The board can decide whether the foundation shall have a general manager or not, or if more than one general manager is to be appointed.


**§ 6 Fullmakter/ Mandatory's**
